

Antonia Brancia Maxon Award for EHDl Excellence

The **Antonia Brancia Maxon Award for EHDl Excellence** honors the career achievements of Dr. Antonia Brancia Maxon in promoting effective EHDl programs for all newborns, infants, and young children. Dr. Maxon was a visionary in EHDl programs, beginning with her leadership in the Rhode Island Hearing Assessment Project in the late 1980's. She was one of the first to recognize the feasibility and value of universal newborn hearing screening and was a tireless advocate for connecting screening programs with timely and appropriate diagnosis and early intervention.

Her extensive contributions to creating excellent EHDl programs were abruptly ended by a tragic automobile accident in May of 2007. In memory of her contributions, an **Award for EHDl Excellence** is presented at the EHDl Annual Meeting to honor an individual or group of people who have made a noteworthy accomplishment that contributed to achieving excellence in EHDl programs nationally or in a particular state or region of the country.

Broadening Perspectives: A Collaboration Between Traditionally Divisive Ideological Camps on Deaf Education

In Fall 2016, the Moog Center, a private oral school in St. Louis, Missouri that teaches children with hearing loss to talk, joined with DEAF, Inc., a non-profit organization that focuses on advocacy and communication access for the deaf community, to pilot a program to broaden perspectives for children with hearing loss and their families.

DEAF, Inc. and The Moog Center recognize that choices regarding methodology of deaf education can be divisive and there is a need to collaborate with parents and families along with their children to understand that this does not have to be the case. Through the creation of safe spaces for dialogue, parents have provided feedback indicating that there is a strong interest in understanding the possible contribution of sign language and the deaf community as a part of social identity development in the deaf child's future as a tool to develop language and social identity along with the importance of Spoken English. Together, these organizations began offering an after-school program for the school students and their parents in an effort to break down barriers and misconceptions, including sign language, and expose children and their parents to the broader deaf community. The collaborative program in which the Moog Center and DEAF, Inc. have engaged has shown promise in bridging often divisive perspectives into the shared pursuit of providing early intervention and language choices for the deaf child and their families.

Betsy Moog Brooks is the Executive Director of the Moog Center for Deaf Education, a non-profit private school that teaches children with hearing loss to talk. She recently earned her Doctor of Education in Instructional Leadership with an emphasis in Andragogy, the study of adult learners. She received her Master's degree in Speech and Hearing from Washington University and is certified in Deaf Education, Behavior Disorders, Learning Disabilities, Early Childhood Education and is a Listening and Spoken Language Specialist. She has been in the field of early intervention for more than 30 years and continues to provide direct child service and parent support to families with children birth to three.

Dr. Thomas Horejes received his PhD in Justice Studies at Arizona State University and is currently Gallaudet University's Associate Provost of Student Success & Academic Quality. Prior to his position at Gallaudet, he was former Executive Director of DEAF, Inc. – based in St. Louis—that provides advocacy and interpreting services to the deaf/hard of hearing community. He has numerous publications, including a book entitled, *Social Constructions of Deafness: Examining Deaf Languacultures in Education*. He is also former professor of sociology at Gallaudet University.

Shine a Light: Fostering Development Across Domains

Early identification of hearing status, early exposure to accessible language, early amplification (where relevant), and implementation of early intervention have benefitted countless children who are deaf or hard of hearing. Building on the shoulders of the giants in our field, research has been undertaken and policies have been introduced that truly promote improved outcomes. With the appropriate early supports, young children with reduced hearing and their families are, in many ways, thriving. This presentation will celebrate some of the successes that we, together, have achieved. It will also serve as a reminder that, despite the enormous progress that has been made, areas of vulnerability remain for many deaf and hard-of-hearing children. By shedding some light on the various domains of development, this presentation will aim to broaden the scope of how we think about and support deaf and hard-of-hearing children. Much of the work in the field has focused intently on language development (whether signed or spoken); yet when we illuminate the needs of the whole child, we bring to light other areas of development that also critically important. Families often possess a flicker of hope regarding the possibilities for their child. Yet, further involving caregivers in the journey to learn more about their child’s development, can fan their flames of passion to help realize the child’s optimal potential.



She has also had the pleasure of teaching as an adjunct faculty member in the Deaf and Hard of Hearing Infants, Toddlers, and Families: Collaboration and Leadership Program at Gallaudet University.
